**How to book:** Reservations may be made through any CAA Niagara office. A non-refundable deposit of \$300 per person is due at time of booking. Balance of payment is due May 3, 2024. **Cancellation charges:** Should it be necessary to cancel your trip prior to departure, the following penalties will apply:

60 days or more prior	Deposit non-refundable
59 to 30 days prior	50% non-refundable
29 to 0 days prior	100% non-refundable

The day of departure is excluded when calculating cancellation charges. CAA strongly recommends the purchase of cancellation insurance.
