How to book: Reservations may be made through any CAA office. A non-refundable deposit of \$200 per person is due at time of booking. Balance of payment is due on December 11, 2020. Bookings made after December 11 will require full payment at time of booking. CAA strongly recommends the purchase of travel insurance. Ask for details.

Cancellation charges: Deposits are non-refundable. Should it be necessary to cancel your trip prior to departure, the following penalties will apply:

60 days or more prior	Deposit non-refundable
59 to 30 days prior	50% non-refundable
29 to 0 days prior	100% non-refundable

The day of departure is excluded when calculating cancellation charges. CAA strongly recommends the purchase of cancellation insurance.

Prices: All prices in this brochure are in Canadian dollars, unless otherwise stated, are based on February 29, 2020 contract rates, and are subject to change should currencies fluctuate, or surcharge be imposed.

Easy Pace: Tour moves at a leisurely pace involving minimal physical activity which includes standing, walking short distances and climbing some steps. A mixture of longer and shorter days with scheduled free time.
