
# AGAWA CANYON FALL TRAIN TOUR

## DAY ONE

L, D

A morning departure takes us to Gravenhurst for a fall colour Muskoka Lakes luncheon cruise. After the cruise, travel north across the French River to Sudbury for our overnight stay. Dinner tonight at the Fionn MacCool.

## DAY TWO

CB, L, D

Following breakfast, we begin our way to Sault Ste. Marie. After lunch, visit the Canadian Bushplane Heritage Museum, which commemorates Canada's history of bush flying and forest fire fighting followed with dinner under the wings. We check in our hotel after supper for a two-night stay.

## DAY THREE

B, BL

An early departure, allows us to board Algoma Central Railway's popular Agawa Canyon Tour Train. Travel on a narrated journey through mixed forest and rugged granite rock formations to the Canadian Shield. Enjoy a box lunch upon arrival in the canyon. Arrival back to the hotel is in the late afternoon. Dinner on own.

## DAY FOUR

B, L

This morning, we depart Sault Ste. Marie and make a picture stop at the Big Nickel in Sudbury followed by lunch, we continue travelling to North Bay for our last night stay. After a long drive we stop for beer tasting and a bit of history at the Gateway City Brewery. Dinner on own.

**Accommodations:** Hampton Inn by Hilton North Bay

## DAY FIVE

CB

Following breakfast, depart for the Canadian Forces Museum of Aerospace Defence where NORAD (North American Aerospace Defence Command) was situated. NORAD is responsible for the famous underground bunker. Other exhibits from the Cold War period include the BOMARC missile, the CF-105 Avro Arrow, Electronic Warfare and more! After this visit, we continue to travel home, with an expected early evening arrival.

The day of departure is excluded when calculating cancellation charges. CAA strongly recommends the purchase of cancellation insurance.
