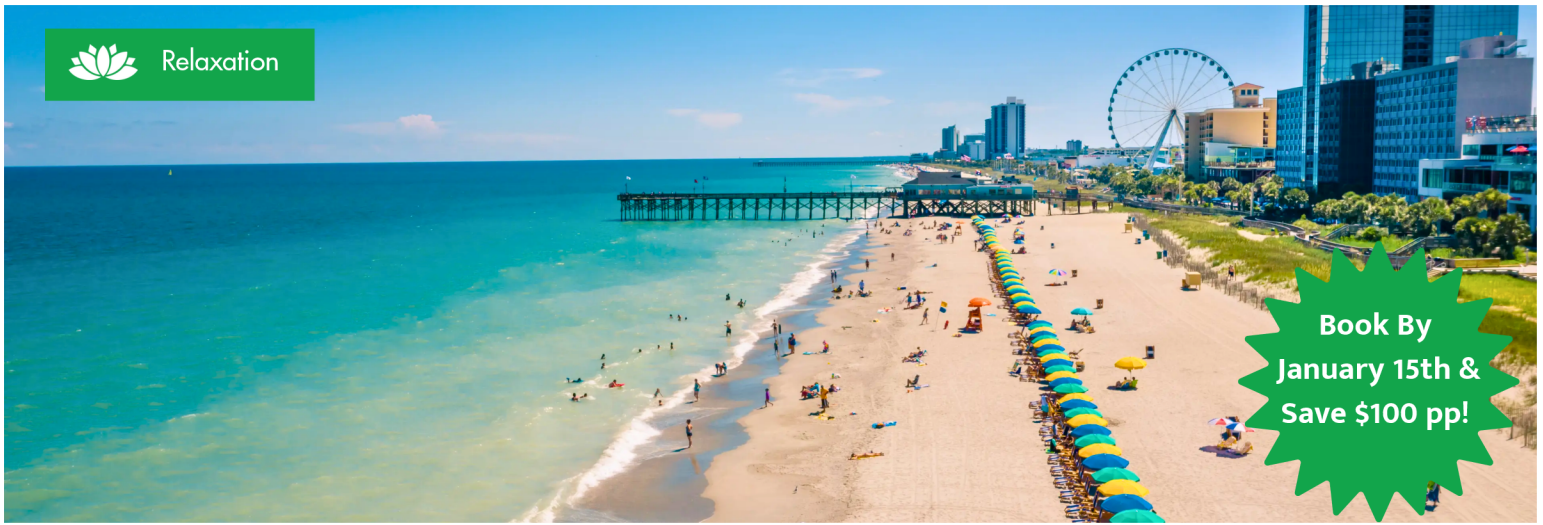

■ SUNDAY, APRIL 19

An early morning departure as we cross into New York State on our way to West Virginia, where we will be staying one night in Summersville.

■ MONDAY, APRIL 20 **B, D**

■ TUESDAY, APRIL 21 **B, D**

This morning and afternoon are free to explore the hotel, enjoy the beach, let your worries float away in the lazy river or take a stroll down the beach to Pier 21 or to the Boardwalk and Promenade. ■ THURSDAY, APRIL 23 **B, D**

Cancellation charges: Should it be necessary to cancel your trip prior to departure, the following penalties will apply:

Prior to February 18	Deposit paid non-refundable
February 19 to 0 days prior	100% non-refundable

The day of departure is excluded when calculating cancellation charges. CAA strongly recommends the purchase of cancellation insurance.

Moderate Pace: Tour moves at a leisurely pace involving minimal physical activity which includes standing, walking short distances and climbing some steps. A mixture of longer and shorter days with scheduled free time.
