Deleting the existing Special Provisions contained in the Letters Patent and Supplementary letters patent, and replacing them with the following.

1. The Corporation is authorized to establish two classes of membership, being Primary Members and Associate Members, as follows

(a) the Primary Members shall be entitled to receive notice of, and to attend all meetings of the members of the Corporation and each Full Member shall have one (1) vote at each such meeting.

(b) Except as otherwise provided by the Not-For-Profit Corporation Act (Ontario) the Associate Members shall not be entitled to receive notice of, or attend at meetings of the members of the Corporation, and shall not be entitled to any right to vote thereat.

The rights, benefits, duties and obligations of membership shall be as set out in the by-laws of the Corporation.

2. Commercial purposes, if any, included in the articles are intended only to advance or support one or more of the non-profit purposes of the corporation. No part of a corporation's profits or of its property or accretions to the value of the property may be distributed, directly or indirectly, to a member, a director or an officer of the corporation except in furtherance of its activities.

3. Upon the dissolution of the corporation and after satisfying the interests of its creditors in all its debts, obligations and liabilities, its remaining property shall not be divided among the members but shall be distributed to a Canadian body corporate that is a registered charity under the Income Tax Act (Canada), or such other organization whose objects are beneficial to the community with similar purposes to the Corporation. Such organization or organizations shall be chosen by ordinary resolution of the board of directors.
